

### **BENNETT RENOVATION**

Bennett Spring Hatchery has already started Phase 1 of 3 on a multi-year \$20 million project that will repair or replace portions of the hatchery's aging infrastructure. This means you may currently be hearing the sounds of machinery and have certain areas of the park closed periodically.

As it is laid out, the renovation should have minimal impact on fishing. Phase 1 should be completed before opening day. Phase 2 is more of a designing stage. Phase 3 is the construction stage. Phase 3 is scheduled to start in 2023 and last for 2 years. Although, the hatchery will be shut down during this stage, fish will be brought in from the other trout parks. Bennett Spring will be stocked daily and anglers will not see any change for the seasons. The closure will not have any impact on the winter stocking program either. #### **INPUT ON MOTORBOAT LIMITS**

The National Park Service (NPS) is seeking input on the motorboat limits set forth in the 2015 General Management Plan (GMP) for ONSR. The 2015 GMP placed restrictions on motorboats of any horsepower on the uppermost stretches of the Current and Jacks Fork River during peak float season (April to mid-September.) However, the horsepower limits have yet to be implemented or enforced, and do not go far enough to limit motorized traffic.

The horsepower limits were passed both to protect life within the river and to enhance the enjoyment and safety of the river for swimmers, canoeists and kayakers. The shallow water and narrow channels make it dangerous for motorized boats to share space with floaters.

These limits were decided after more than 1,400 people attended public meetings and more than 3,000 people submitted written public comments. 83% of the commenters were Missourians.

Noise pollution, wake, and fumes not only affect floaters, but also disturb the wildlife that evolved to live in the natural environment along these rivers. The NPS draft plan explains that limiting motorboats "could help reduce the threat of water quality degradation from petroleum-based pollutants resulting from motorboats in these areas during the peak season." Additionally, powerful motorboats generate wakes that erode the river banks and disrupt fish nests on the river bottom. Tell NPS: Implement Horsepower Limits on the
